 $\rightarrow$  Is the author trying to convince you to believe a certain ideology?

Even though the Holocaust is one of the most well-documented historical events of all times, there is still a lot of hatred towards the Jews, which is the primary reason why so many people are focused on convincing others that the genocide of the Jews never happened. In fact, revisionists try to spread the idea that Jewish people have invented this genocide in order to advance their interests in the world. Thus, a lot of people speculate that Jews have a desire to dominate the world and create tons of conspiracies which, of course, are not based on any facts.

Taking everything into consideration, revisionists are still trying to deny the genocide of the Jews even though there is lots of evidence that supports the fact that the Holocaust happened.
